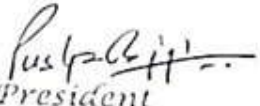

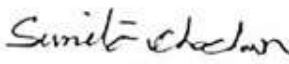


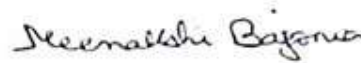
Memorandum of Association

1. **Name of the association:** Shubham Charitable Association
2. **Address of the registration:** 181, Ashirvad, Lower Jail Road Shillong- 793001, East Khasi Hills District, Meghalaya.
3. **Date of Establishment:** 28th July 1998
4. **Nature of Society:** This Society is a not-for-profit, non-political, voluntary and non-governmental organization. It is initiated and governed by its own members on democratic principles, without any external control. It does not profess or promote any religious/communal/divisive beliefs or doctrines.
5. **Objectives of association:**

 - e) To work for the empowerment of persons with disabilities, i.e. visual, hearing, speech, loco motor and mental disabilities, covering various aspects namely, prevention, early detection, intervention, education, vocational training, rehabilitation and social integration etc.
 - f) To work for the improving socio-economic conditions of the minority communities by promoting economic and developmental activities, self-employment and other ventures. To facilitate an equitable share for minority communities in education, employment, economic activities and to ensure their upliftment.

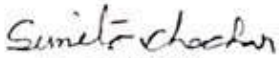

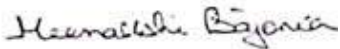

This could mean that he was in some way involved in the kidnapping. Or, more likely, it could mean that he was in some way involved in the investigation.

 - Audited Statement of Expenditure giving detailed expenditure as per sanctioned Expenditure Heads along with PFMS transaction IDs and dates of transaction.
